

TENANT CRITERIA AND SCREENING REQUIREMENTS

TO APPLY, THE FOLLOWING IS REQUIRED:

- 1. Each applicant 18 and over must complete and sign an application.
- 2. A \$15.00 application fee must accompany each application. (Cash or Money order only)
- 3. Each applicant must present a current form of photo identification in person.
- 4. Each applicant must show verification of social security number.
- 5. All applications must be filled out completely to be considered.

THE FOLLOWING ARE OUR POLICIES AND PROCEDURES:

- 1. Qualifying is based on: 1) Income, 2) Court Records Search (crime, judgments, etc), 3) Rental History or Home Ownership, 4) Credit History.
- 2. Income must be verifiable.
- 3. Any false information given on the application shall be grounds for denial.
- 4. The application fee is non-refundable, if processed.
- 5. If approved, your \$15.00 application fee will be credited towards the first month's rent.
- 6. If approved, the security deposit must be paid in full to hold a property.
- 7. If approved, all applicants will be required to sign the lease.
- 8. The applicant that is offered the property will be notified by telephone.
